The District estimates a total fund balance of \$1,386,085 at the end of Fiscal Year 2020-2021.

The District anticipates expenditures of \$191,580 during Fiscal Year 2021-2022.

The District allocates \$191,580 of the total fund balance to the Operating Fund effective October 1, 2021.

The District allocates the remainder of the total fund balance to the Reserve Fund effective October 1, 2021.

The District commits the monies of the Reserve Fund in equal portions to groundwater conservation, groundwater management, groundwater monitoring, groundwater protection, groundwater research, groundwater resource planning, and legal contingencies with the adoption of this budget.

Estimated Required Tax Rate (Texas Water Code 36.154(b)(7))

The District anticipates revenue from sources other than tax-related sources to be \$1,500.

The District requires tax-related revenue exceeding \$197,336 to avoid a budget deficit in Fiscal Year 2021-2022.

The District estimates that a Tax Year 2021 tax rate of \$0.01826/\$100 of taxable value is required for Fiscal Year 2021-2022 and the use of \$9,912 of the Reserve Fund to avoid a budget deficit. The tax levy for Tax Year 2021 is estimated to be \$180,168.
